Location Works customer privacy policy

Location Works is committed to protecting your personal information. Our Privacy Policy contains important information about what personal details we collect; what we do with that information; who we may share it with and why; and your choices and rights when it comes to the personal information you have given us. When you make an enquiry about the goods or services we supply or purchase services from us, you may need to provide us with certain personal data relating to you. Your privacy is extremely important to us so we want you to know exactly how we will use that personal data. We've set out all the details below.

Main points:

- :: We will only ever ask for what we really need to know;
- :: We will collect and use the personal data that you share with us transparently, honestly and fairly;
- :: We will always respect your choices concerning the data that you share with us;
- :: We will put appropriate security measures in place to protect the personal data that you share;
- :: We will never sell your data.

Who we are

Our full name is Location Works Limited. We will be the data controller in respect of any personal data you provide to us. The term "data controller" is a legal phrase used to describe a person or entity that controls the way personal data is used and processed.

Information we collect and use

Information about you that we collect and use includes:

- :: information about who you are e.g. your name and contact details;
- :: your bank account details (so that we can make payments and refund deposits);
- :: information about your contact with us e.g. notes on phone calls & emails;
- :: information that is automatically collected e.g. via cookies (see below) when you visit our website. We only collect personally identifiable information to the extent that it is reasonably necessary to serve the legitimate business purposes of Location Works Ltd. We maintain appropriate safeguards to ensure the security, integrity and privacy of the information you have provided to us. We would not normally transfer your information to third parties, but if we did, we would take all reasonable steps to ensure that third parties to whom we transfer any data also provide sufficient protection of that personal information. We do not collect or store credit or debit card details. We do not collect or store 'sensitive' personal information about you, since that is not required for our day-to-day business.

Use of your information

We use the personal information we hold about you:

- :: to provide you with our services;
- :: to enforce our contract with you and inform you of any changes to the contract;
- :: in both of these cases the legal basis that we will be relying upon to process your personal information, will be because it is necessary for the performance of the contract between us. We also use the information we hold about you:
- :: to provide you with information about services you have enquired about;
- :: to obtain feedback from you and provide ongoing customer service;
- :: to deal with any complaints;

:: in this case our legal basis for processing your personal information will be because the processing is in our legitimate interests, namely to provide you with a high level of service, resolve complaints and to promote our business. We may also, to enforce the law, and when required to do so, disclose information to law enforcement agencies.

Your consent

By using our website, you signify your consent to this Privacy Policy. If you do not agree to this policy, please do not use the website. We reserve the right to make changes to Our Privacy Policy. Any change to the policy will be published on this page so that you can always be aware of it. Your continued use of the site signifies your acceptance of these changes.

Individual rights

Data protection legislation provides individuals with a number of different rights in relation to their data. For example, you have the right to ask us whether we hold information about you and if so, to obtain certain details about that information and/or the information itself. Exercising this right is commonly known as a 'data subject access request' (DSAR). Certain exemptions and conditions apply to this right. There are other rights which you also may be able to exercise (such as the right to have inaccurate personal data rectified, to object to the processing of personal data, or to require the erasure of personal data). Cookie Policy

- :: Like many web sites the Location Works web site makes use of cookies. A cookie is a small amount of text-only information that is saved to your computer's hard disk by your web browser so that the web site can remember who you are. Cookies cannot be used by themselves to identify you although they may be used to record your IP address. A cookie will typically contain the name of the domain from which the cookie has come, the "lifetime" of the cookie, and a value, usually a randomly generated unique number.
- :: Location Works may use necessary cookies/performance cookies/functionality cookies on its web site, specifically:
- :: per session cookies, which are temporary cookies that remain in the cookies file of your browser until you leave the web site;
- :: persistent cookies, which remain in the cookies file of your browser for longer (depending on the lifetime of the specific cookie). These cookies are used to store information between visits to a site.
- :: None of the Location Works cookies keep any personal information about you or any of our visitors.
- :: Third party web sites to which you may be redirected by whatever means from the Location Works web site may also use cookies.

- :: Location Works uses cookies to help it understand more about how the web site is used and to provide you with a more personalised web service by, for example, remembering which pages you have visited, and helping you navigate between sections.
- :: If you do not wish to receive cookies you can easily modify your web browser to refuse cookies or to notify you when you receive a new cookie. However, you may not be able to use all the interactive features of the web site if cookies are disabled and we recommend that you leave them switched on.
